McCall Woodworks Custom Furniture is requesting a conditional use permit for a shop to mill logs and build furniture.

There are two buildings adjacent to each other. The south building with the missing roof will be partially demolished. The north building will be reinforced. A fenced area will be used to store logs, other materials, and a port-potty. The building is located on asphalt. It was previously used as a storage facility. All exterior lighting will be night sky compliant. The public will not have access to the shop.

The site is 1.6 acres addressed as 13239 Highway 55. The site would be accessed via an existing shared driveway from State Highway 55, a paved, public road.




