Jeff Abrams is requesting a conditional use permit for a short-term rental of a yurt that does not qualify as a residential dwelling.

The 16-ft diameter yurt has four bunks, a woodstove, a two-burner stove, a sink, and an outdoor cistern. There is a pit privy.

The 10-acre parcel is RP17N04E082915, addressed at 400 Silver Fox Spur.

The yurt is accessed from a private road.




