Project Description:

Robert Workman is requesting a vacation of a 10-foot-wide utility easement that is centered on the lot line between Lot 74 and Lot 75 Block C of Wagon Wheel Ranch #4.

The applicant owns both lots. Removal of the easement would allow building to occur in the existing easement area.






