Facility Manager, Scott Clingan requested an extension to present to the commissioners regarding the purchase of skid stir. He advised that Buildings & Grounds was considering sharing the piece of equipment with the Valley County Road Department and advised that they would be meeting with the salesperson at CAT Equipment on November 23, 2020. He requested that the decision/discussion be placed on the agenda for December 7th.

Road & Bridge Superintendent, Jeff McFadden provided an update regarding work that the Valley County Road Department had been conducting over the past month. He provided an overview of work that will be needed for the Stibnite repair and payment from FEMA. He advised that the work might be contracted out depending on the requirements. Jeff provided an overview of the snow removal that had been done since the last snowstorm and explained that there had been an increased request for sand on roads which is not typical protocols. The commissioners informed Jeff about phone calls that they had received regarding specific locations of concern for snow removal. Chairman Hasbrouck asked Jeff about cement barriers that had been erected near No Business Road which was impacting snow grooming program. Commissioner Bingaman advised that Planning & Zoning Administrator, Cynda Herrick informed him that the area was private land. The commissioners advised that they would continue to research the matter and potential discuss with the landowner McCall Associates LLc.

Commissioner Bingaman asked Mr. Turlington if Tamarack and any thoughts about entering into a further road maintenance agreement for the up coming winter. Mr. Turlington advised that he discuss with Valley County Road Superintendent, Jeff McFadden and have the matter be placed on another upcoming commissioners' agenda. Mr. Turlington informed the commissioners that Phase 1 was almost completed, and he presented that there would be five additional restaurants opening at Tamarack Resort.

The commissioners recessed for lunch at 11:34 a.m.

She reported on the responses that were received regarding the notice. She presented on the process through Valley County Planning & Zoning Commission.

Chairman Hasbrouck opened the Public Hearing for Ordinance No. 21-02 Snowmobile Ordinance at 1:09 p.m. Chairman Hasbrouck asked if there were any ex-parte or conflict of interest. All commissioners advised that there was no ex-parte communication or conflict of interest.

Planning & Zoning Administrator, Cynda Herrick provided a staff report to the commissioners regarding the proposed ordinance No-21-02 Snowmobile Ordinance. She reported on the responses that were received from the individuals who submitted comments to the commissioners. She reported on additional exhibits that had been submitted to the commissioners for consideration.

Chairman Hasbrouck requested to hear from the applicant. Recreation Director, Larry Laxson provided testimony to the Valley County Board of County Commissioners as the applicant. Larry provided general responses to a few of the comments that were submitted to the commissioners. The commissioners had questions for the applicant regarding commercial vehicles in Francie Wallace Parking Lot and private vehicles who leave their vehicles overnight. Larry discussed the parking issues at Francie Wallace. Chairman Hasbrouck asked about removing Andersen Creek from the proposed ordinance No-21-02. Planning & Zoning Administrator, Cynda Herrick advised that at the recommendations of the Valley County Prosecuting Attorney, Carol Brockmann it was removed from the proposed ordinance No-21-02. Commissioner Maupin again asked about the commercial vehicles being able to park with out cost at Francie Wallace. Recreation Director, Larry Laxson responded and advised that IDPR would not allow any fees charged to commercial vehicles. Planning & Zoning Administrator, Cynda Herrick read into the record that addresses overnight vehicles only allowed in designated areas. Commissioner Bingaman requested clarification regarding Brush Creek and East Side Drive. Planning & Zoning Administrator, Cynda Herrick read into the record the sentence related to the area. Recreation Director, Larry Laxson advised that there should be specific language that spells out the specific area.

Chairman Hasbrouck asked to hear from anyone who was a proponent to ordinance No-21-02.

Mr. Mark Wood who resides in McCall, Idaho, presented to the commissioners as a proponent of ordinance No-21-02. Mr. Wood also commented on the parking issues at Francie Wallace Parking Lot and explained that the McCall Snowmobile Club was working on a proposal. Commissioner Bingaman voiced concerns that there was nothing in the proposed ordinance to address the issue of vehicles being parked in parking lots overnight. The commissioners discussed the issue in detail and believed that it was a topic that might need to be decided in the future. Mr. Wood believed that long term parking should be addressed at some point in time but move forward with the proposed ordinance as written.

Mr. Scott Harris who resides in McCall, Idaho, presented to the commissioners as a proponent to the proposed ordinance No-21-02 and wanted to make sure that there would be designated parking available. Recreation Director, Larry Laxson again informed the commissioners about the proposed designated parking that would be available. Mr. Harris did have concerns regarding the proposed ordinance. Sheriff Bolen discussed the liability of leaving vehicles on the roadway.

Commissioner Maupin explained that the County may not have the equipment that would be needed.

Chairman Hasbrouck asked to hear from anyone who was an opponent to the proposed Ordinance No-21-02.

Mr. Jay Jacques who resides in Donnelly, Idaho, presented to the commissioners as a proponent & opponent to the proposed ordinance No-21-02 and requested additional modifications to the proposed ordinance.

Mr. Kimbell Gorley who was representing Aspen Wood Holdings presented to the commissioners as an opponent of the proposed Ordinance No-21-02 and provided an overview the reason for the opposition.

Mr. Ed Priddy who resides in Eagle, Idaho, but has property in Valley County presented to the commissioners as an opponent of the proposed Ordinance No-21-02 and provided an overview the reason for the opposition.

The commissioners discussed Anderson Creek Road and the area involving Anderson Creek. Planning & Zoning Administrator, Cynda Herrick provided information to the commissioners regarding the existing issues related to Anderson Creek area.

Mr. Ed Priddy read an easement regarding ownership of the Anderson Creek Road and believed that Valley County should not add Anderson Creek Road back into the proposed Ordinance No-21-02.

Mr. David Ferdinand presented to the commissioners that he was in opposition to the proposed ordinance and specifically related to Anderson Creek Road.

Mr. Geoff Hines who resides in Star, Idaho, and has property in Anderson Creek Road presented to the commissioners an opponent to the proposed Ordinance No-21-02 as it relates to closure of Anderson Creek Road.

Mr. Jay Jacques again presented to the commissioners regarding his concerns about the potential penalties of right of way violations.

Recreation Director, Larry Laxson provided additional testimony to the commissioners and answered questions related to the special permit process for tracked vehicles. Planning & Zoning Administrator, Cynda Herrick also provided additional matters to the commissioners to take into consideration to include in the proposed Ordinance No-21-02.

Chairman Hasbrouck advised that the commissioners would be tabling the Public Hearing related to Ordinance No. 21-02 Snowmobile Ordinance for December 7, 2020, at 1:30 p.m.

Mr. Richard Avila who owns property at 12966 Zoon Lane in McCall, Idaho, presented his request for Valley County to provide winter maintenance at his address. Mr. Avila advised that he and his wife are planning on moving in the middle of December of 2020. Planning & Zoning Administrator, Cynda Herrick provided testimony to the commissioners and discussed the Road Development Agreement that was put in place for the subdivision. She referred to the commissioner meeting minutes of November 27, 1995, that requested Valley County Road

Department add the subdivision to year-round maintenance since the developer built the road up to county specifications. The commissioners advised that they would discuss the matter with the Road Superintendent, Jeff McFadden and let Mr. Avila know about the possibility of providing winter maintenance to the area.
