

## Valley County Waterways Advisory Committee Meeting

### **Agency Updates**

**Budget Discussion- Clerk Douglas Miller.** Mr. Miller distributed the budget comparison report for FY 24, FY 25 and FY 26 for budgeting purposes. These reports show the actual expenditures from 2024, what has currently been spent in 2025 and the proposed budget for 2026. Mr. Miller needs projects and estimates submitted to him by the next meeting in July so he can finalize the budget. IDPR representatives, Matt and Zach, will get their proposed projects to Jally by the July meeting.

Sheriff Copperi brought up the need for RV spots at the Lakefork Boat Barn. The property has room for this type of use. Sheriff Copperi, Kevin Turner and Jally Zeydel will look into this and report back during the July meeting.
