Chairman Maupin made a statement regarding the tragic event that occurred in Northern Idaho.

Action Item: Chairman Maupin presented the commissioners' agenda for June 30, 2025. Commissioner Thompson made a motion to approve the commissioners' agenda for June 30, 2025. Action Item: Chairman Maupin made a motion to go into Executive Session per Idaho Code 74-206 (c)-"To acquire an interest in real property not owned by a public agency."-Acquisition Commissioner Caldwell seconded the motion. No further discussion, by roll call vote all commissioners voted "aye." The commissioners went into Executive Session per Idaho Code 74-206 (c)-Acquisition at 9:07 a.m.

Chairman Maupin brought the commissioners out of Executive Session per Idaho Code 74-206 (c)-Acquisition at 9:23 a.m. Commissioner Caldwell made a motion to proceed with the purchase of land as discussed in Executive Session. Commissioner Thompson seconded the motion. No further discussion, all in favor. Motion passed to proceed with the purchase of land as discussed in the Executive Session.

Action Item: Mr. Jordan Messner with Idaho Fish & Game presented to the commissioners a request for additional material for Brown's Pond. He described the existing project with the commissioners and explained that material would be used for the parking area. He advised that the initial request was for an additional 200 cubic yards of material but there was a need for 400 cubic yards. The commissioners had questions for Mr. Messner, and he responded accordingly. He also advised that there would be an additional 6 to 8 parking spaces. Commissioner Thompson made a motion to approve the additional 200 cubic years of road material. Chairman Maupin seconded the motion. During further discussion Commissioner Caldwell wanted to clarify where the material would be extracted from. Chairman Maupin explained that the material would be coming from the Lake Fork pit. No further discussion, all in favor. Motion passed to allow the additional contribution of 200 cubic yards of material to Idaho Fish & Game for improvements of Browns Pond.

Chairman Maupin began the workshop related to discuss future road validation process and opened it up for discussion. Road Engineer, Dan Coonce began the discussion and felt that a strategy needed to be developed from a prospective of the road department/weed department and determine if the road even meets Valley County standards. Those in attendance of the workshop were Chief Deputy Prosecuting Attorney, Brian Oakey, Recreation Director, Dave Bingaman, Planning & Zoning Director, Cynda Herrick. The commissioners and those in attendance had the opportunity to discuss specifics regarding the existing road validation process and attempted to outline future steps that should be established. There was a suggestion for creating a project led by Chief Deputy Prosecuting Attorney, Brian Oakey. There was a suggestion for creating a process where whatever division was bringing the road validation, they would lead the project from start to finish. Recreation Director Bingaman will take the lead on completing the Old Council Rd project. Steps were outlined on creating a process moving forward to identify, research and codify roads important to the county.

Action Item: Fire Mitigation Director, Mara Hlawatschek presented the contractor services agreement for the Silver Creek Brush Management East McCall Unit 4. Commissioner Caldwell made a motion to approve the contractor services agreement for the Silver Creek Brush Management East McCall Unit 4. Commissioner Thompson seconded the motion. Action Item: Grant Writer, Ken Schlegel presented the quarterly federal financial report for USDA Woody Debris Grant and advised that there was an additional \$46,000 left to spend. She provided several letters of support from agencies within Valley County that would be willing to assist with the opening of the day care center.

Road Engineer, Dan Coonce began the Valley County Road Department budget workshop with the commissioners and Clerk, Douglas Miller provided an overview of projected revenue and Dan presented on proposed projects for Fiscal Year 2026.

Durena Farr and John Lillehaug with Valley Soil & Water District provided a presentation to the commissioners and provided a handout which will be appended to the commissioner meeting minutes. The commissioners had the opportunity to interact with Valley Soil & Water District members and Durena and John responded accordingly. The commissioners advised that a

Memorandum of Understanding needed to be developed and explained the reasons for the requirement. The commissioners appreciated the presentation from Valley Soil & Water District.
