
Commissioner Caldwell recused herself from the bid opening and was not in attendance.

Action Item: Road Department Director, Jeff McFadden presented the bids to the commissioners for the Abstein Bridge Project. Veritas Services & Construction, Granite Excavation, and Moreno & Nelson Construction Corp. submitted bids by the deadline. Chairman Maupin opened the bids. Veritas Services & Construction was opened first. Total bid amount was \$1,849,777 from Veritas Services & Construction. Granite Excavation was opened next. Total bid amount was \$2,105,039 from Granite Excavation. Moreno & Nelson Construction Corp. out of Eagle, ID was opened last. Total bid amount was \$1,225,000 from Moreno & Nelson Construction Corp. The Parametrix Engineer requested to verify compliance criteria before approving the apparent low bid. Chairman Maupin tabled the bid approval until further review. Bid approval scheduled for August 27th at 11:30 a.m.

The commissioners adjourned the meeting at 3:15 p.m.
