Commissioner, Neal Thompson led the Pledge of Allegiance.

Action Item: Commissioner Thompson advised that there needed to be an amendment to the agenda to add an approval of a bid for bituminous surface treatment, approval of allowing Ignite Idaho to build a fence at the Cascade Community Center and moving the Executive Session for litigation to 1:00 p.m. Commissioner Caldwell made a motion to approve that agenda for August 6, 2025, with the proposed amendments. Commissioner Maupin seconded the motion. No further discussion, all in favor. Motion passed to approve the commissioner's agenda for August 6, 2025, with the amendments to add an approval of publishing a bid for bituminous surface treatment, approval of allowing Ignite Idaho to build a fence at the Cascade Community Center and to move the Executive Session for litigation to 1:00 p.m.

Action Item: Sheriff Kevin Copperi made a request to the commissioners to utilize an outbuilding at the Valley County Road Department to store the firewood for the Chop with A

Cop program and explained the program but advised that there was a need for a facility to store the firewood. He presented the difficulties finding a location to store firewood to keep it dry. The commissioners had questions related to potential locations and made suggestions to find alternative solutions to include the local churches, local businesses and city of Cascade. No decision was made by the commissioners as the road department would not be able to provide any outbuildings during the times that storage is needed.
