No further discussion, all in favor. Motion passed to reappointment Commissioner, Elting Hasbrouck as the Valley County Board of County Commissioners Chairperson for calendar year 2021.

Treasurer, Gabe Stayton informed the commissioners that he swore in Ms. Jody Green as the new Chief Deputy Treasurer. Chairman Hasbrouck advised that the recess for the Watershed Summit was not until January 25, 2021, and they would be going back to the agenda. Commissioner Maupin seconded the motion. No further discussion, by roll call vote all commissioners voted "aye". The commissioners went into Executive Session per Idaho Code 74-206 1(b)-Personnel at 10:10 a.m.

Chairman Hasbrouck brought the commissioners out of Executive Session per Idaho Code 74-206 1(b)-Personnel at 11:30 a.m. No decision was made after the Executive Session per Idaho Code 74-206 1(b).

Chairman Hasbrouck advised that the commissioners would be recessing until 1:00 p.m.

The commissioners reconvened at 1:00 p.m.

Chairman Hasbrouck presented the commissioner meeting minutes of January 4, 2021. Commissioner Bingaman made a motion to approve the commissioner meeting minutes of January 4, 2021. Commissioner Maupin presented to the commissioners on the creation of the Road Advisory Committee and the reason that she individually created the committee. She advised that at the last meeting there was a request to add additional individuals. She advised that one of the individuals that had asked to participated believed that the Road Advisory Committee should complying with open meeting laws and Commissioner Maupin felt that the Valley County Board of County Commissioners should formally designate the Road Advisory Committee as an official sub-committee which would then require the commissioners to appoint the participants. She also advised that the Valley County Road Advisory Committee then publish the agendas and meeting minutes. Road Superintendent, Jeff McFadden provided his opinion to the

commissioners and advised that he would be in support of a formal Road Advisory Committee. Commissioner Bingaman and Chairman Hasbrouck voiced their support of the creation of a subcommittee. Chairman Hasbrouck made a motion to designate the Road Advisory Committee as an official Valley County Sub-Committee. Commissioner Bingaman seconded the motion. No further discussion, all in favor. Motion passed to designate the Road Advisory Committee as an official Valley County Sub-Committee.

Chairman Hasbrouck began the update to the commissioners regarding the boards that he attends. He reported on the District IV Central District Health Board that he participates on. He advised that the Boise Forest Coalition had not met since December of 2020. He provided a brief update on the LEPC Board meeting that he attended and matters that have been discussed. Commissioner Maupin reported on the WCEDC meeting that she had attended and presented on the early childhood education grant that was awarded. She advised that a plan had been created and they would work on implementation. She presented that they were still discussing broadband grant. She advised working on a creation of Community Economic Development Study. Commissioner Maupin advised that she would be attending the Valley County Fair Board meeting on January 11, 2021 and explained that the agendas would be published on the Valley County Website. She provided an update regarding the District IV Mental Health Board that she participates on and described the funding that awarded to the board. She reported that she was attending the monthly meetings regarding SRS funding and PILT funding and informed the commissioners that SRS had not been reauthorized, but she would continue to advocate for future funding. She also presented on the IAC Legislative committee. Commissioner Bingaman provided an overview of meetings and board that he had attended including the Stibnite Mine Project. He discussed the presentation that was submitted. He presented on the Waterways Committee and advised that they were interviewing two organizations for the Waterways Study. He informed the commissioners about the Recycling Center Committee and the discussions that would be taking place with the city of McCall and the city of Cascade. Chairman Hasbrouck reported on the Snowmobile Advisory Committee meetings. Commissioner Bingaman advised that the WICAP Board did not have enough active participants and they would be reconvening in the future.

Chairman Hasbrouck announced that the commissioners would be having a Public Hearing for VAC 20-01 Vacation of Portion of Cheyenne Road and opened the public hearing at 1:34 p.m. Chairman Hasbrouck if there was any ex-parte communication or conflict of interest. All commissioners advised that there was no ex-parte communication or conflict of interest related to VAC 20-01 Vacation of Portion of Cheyenne Road. Chairman Hasbrouck asked for a staff report.

Planning & Zoning Administrator, Cynda Herrick provided a staff report to the commissioners regarding VAC 20-01 Vacation of Portion of Cheyenne Road. She advised that the Valley County Planning & Zoning Commissioner unanimously voted to approve the vacation of a portion of Cheyenne Road.
