Clerk, Douglas Miller presented on the amount of Title III Funds that would be available for the expenditures for the equipment for the new recreation patrol positions. He advised that the requested equipment totaled \$250,000 and that would completely deplete the funds available through Title III. He recommended that a portion of Title III Funds be utilized for the expenditures and PILT Funds. Commissioner Maupin made a motion to expend \$100,000 out of Title III funds and the remaining amount to be expended from the PILT fund for the Recreation Patrol positions equipment as requested by the Valley County Sheriff's Office. Commissioner Allen seconded the motion. No further discussion, all in favor. Motion passed to expend \$100,000 from Title III funds and the remaining amount to be expended from the PILT fund for the recreation patrol positions equipment as requested by the Valley County Sheriff's Office.

Recreation Director, Larry Laxson began the discussion related to the outline and by-laws and operations of the Valley County Recreation Advisory Board that the Recreation Department had created for the commissioners to review and consider approving. The commissioners deliberated on the outline and by-laws that had been prepared and presented by Recreation Director, Larry Laxson. The commissioners had the opportunity to ask specific questions to Larry Laxson and he responded accordingly. Recreation Planner, Dave Bingaman also

provided an explanation to the commissioners of what the Recreation Department was attempting to accomplish with the creation of by-laws. Chief Deputy Prosecuting Attorney, Brian Oakey provided additional recommendations to the commissioners for the commissioners to set the projects for the advisory committees and informed the commissioners that open meeting laws would apply to the newly created Valley County Recreation Advisory Board. The commissioners continued to deliberate on the proposal that was made regarding the members of the advisory committee meeting and each commissioner provided their suggestions on who should be active participants on the advisory committee and what the proposed mission statement should be. Recreation Director, Larry Laxson provided recommendations to the commissioners. Recreation Planner, Dave Bingaman further provided his opinion to the commissioners regarding the creation of the strategic plan of the recreation advisory committee. He advised that conservation should be a part of advisory committee. The commissioners again provided suggested recommendations to the proposed outline and bylaws of the proposed Valley County Recreation Advisory Board. Captain, Dave Stambaugh with the Valley County Sheriff's Department also requested a seat on the recreation advisory committee. The commissioners requested additional work be conducted on the outline and bylaws and bring the matter back to the commissioners for a formal decision to be made regarding the creation of the Valley County Recreation Advisory Board.

Valley County Public Defender, Scott Erekson provided the commissioners with an overview of public defender cases that were handled in Fiscal Year 2022. He explained to the commissioners the new requirements of the Public Defense Commission for reporting cases. He advised that the case load from Fiscal Year 2021 to Fiscal Year 2022 increased by 14%. The commissioners discussed the new state public defense system and briefly discussed options that were being proposed by the Idaho Association of Counties and state legislators. The commissioners continued to discuss possible options for a statewide public defender system and how it might impact Valley County. Mr. Erekson concluded his presentation to the commissioners.

Chairman Hasbrouck made a motion to go into Executive Session per Idaho Code 74-206 1(f)"To communicate with legal counsel for the public agency to discuss the legal ramifications of

Chairman Hasbrouck brought the commissioners out of Executive Session per Idaho Code 74-206 1(f)-Litigation at 11:21 a.m. No decision was made after the Executive Session per Idaho code 74-206 1(f)-Litigation.

Treasurer, Johanna Defoort began the discussion/decision regarding the commercial Solid Waste Fee #7 from Resolution 22-19. She advised that the decision that the commissioners need to make would be to what should the commissioners set the commercial solid waste fees for the business that have a trash compactor. She explained the process that was developed to determine a fair fee for the business that have individual trash compactors and consider the amount of tons of trash that was hauled. Facilities Director, Scott Clingan provided information to the commissioners regarding the work that was conducted by the employees at

the transfer site to capture the data related to the amount of waste that has been collected. Commissioner Allen made a motion to adopt Scenario #2 for Solid Waste Fee #7. Commissioner Maupin seconded the motion. No further discussion, Chairman Hasbrouck and Commissioner Allen voted in favor. Commissioner Maupin voted against. The motion passed with a 2-1 vote. Motion passed to adopt Scenario #2 for commercial solid waste fee #7 as outlined on Resolution 22-19.

Mrs. Deborah Fereday who resides in McCall, Idaho, presented to the commissioners a request that the Valley County Board of County Commissioners request a 30-day extension from the U.S. Forest Service for the comment period for the supplemental environmental impact statement for Stibnite Gold Project. The commissioners had the opportunity to ask Mrs. Fereday questions regarding her request. Mrs. Fereday responded accordingly. The commissioners deliberated on the matter and shared their opinion with Mrs. Fereday. Mrs. Fereday made closing arguments to the commissioners regarding her request. Commissioner Allen provided his opinion and made sure he was clear on the request from Mrs. Fereday. The commissioners declined to act regarding the request from Mrs. Deborah Fereday.

The commissioners recessed for lunch at 12:04 p.m.
