## IN THE OFFICE OF THE VALLEY COUNTY BOARD OF COMMISSIONERS CASCADE, IDAHO January 3, 2023

Lieutenant, Michael Lacroix led the pledge of allegiance.

Chairman Hasbrouck presented the commissioners' agenda for January 3, 2023. Commissioner Maupin made a motion to approve the commissioners' agenda for January 3, 2023. Commissioner Allen seconded the motion. No further discussion, all in favor. Motion passed to approve the commissioners' agenda for January 3, 2023.

Chairman Hasbrouck presented the commissioner meeting minutes from December 27, 2022. Commissioner Allen made a motion to approve the commissioner meeting minutes of December 27, 2022. Commissioner Maupin seconded the motion. No further discussion, all in favor. Motion passed to approve the commissioner meeting minutes of December 27, 2022.

Clerk, Douglas Miller presented on the Valley County Indigent Defense Expenditure Report for Fiscal Year 2022. The commissioners had questions regarding the report and Clerk Miller responded accordingly. The commissioners had additional questions regarding the increased amount of acreage that would be added from 2 acres to 4.4 acres. Recreation Planner, Dave Bingaman provided clarification regarding the additional acres that was added to the grant and explained that it would not impact any future growth of the Valley County Road Department. Commissioner Allen made a motion to approve the Land Water Conservation Fund Grant for the Valley County Pickleball Club. Commissioner Maupin seconded the motion. No further discussion, all in favor. Motion passed to approve the Land Water Conservation Fund Grant for the Valley County Pickleball Club.

Chairman Hasbrouck began the discussion/decision regarding the applicants for the Recreation Advisory Committee. The commissioners discussed the process of selecting members of the recreation advisory committee. Recreation Planner, Dave Bingaman provided his input to the commissioners regarding the selection process. The commissioners also provided their input regarding the selection process of the Recreation Advisory Committee and their actual function. The commissioners proposed selecting 12 advisory committee members individually and providing the selections to the Recreation Department for the Recreation Department to narrow down for actual interviews. The commissioners had opportunities to ask questions to Cynda and she responded accordingly. The commissioners also had the opportunity to ask specific questions regarding the recommendations of the impact areas. Planning & Zoning Director, Cynda Herrick presented on Resolution 23-04 Adoption of Capital Improvement Program and explained the resolution to the commissioners regarding the impact of the resolution for the Valley County Road Department. Commissioner Maupin provided her opinion regarding the proposed resolution and felt that road improvements should not be paid for by existing homeowners and should be paid for by future development utilizing the Capital Improvement Program. Chairman Hasbrouck had questions regarding Valley County adopting a resolution or a formal ordinance. Planning & Zoning Director, Cynda Herrick explained the process to the commissioners. Commissioner Allen made a motion to adopt Resolution 23-04 Adoption of Capital Improvement Program as outlined. Commissioner Maupin seconded the

motion. No further discussion, all in favor. Motion passed to approve Resolution 23-04 Adoption of Capital Improvement Program.
