- 3. Justice Programs (Treatment Court / Diversion):
 - a. Review 1st Quarter reporting update by Susan Hilger. Reporting was submitted and received funds on 6/2/25.
 - b. 2nd Quarter report progress update by Susan Hilger. Quarter ended and preparations are ready for submission.
 - c. Clinical Collaboration update by Susan Hilger. Discussed collaboration with Scenic Bluffs and then coming to Prairie du Chien. Working on funds modification to get them on board. Since the position was eliminated, the funds for the peer support person will be moved to that group of funds. One participant is already going to Cashton.
 - d. Drug testing procedure update by Susan Hilger. Contract signed with Crawford County Jail. Met with Dale and Butch in April. Testing now happening in June.
 - e. New referrals update by Susan Hilger. Not a lot of referrals right now for Treatment Court. Diversion is taking off. Hoping for 20 participants by the end of this year.
 - f. Project Design Table update by Susan Hilger. Submitted to DOJ and she has received good feedback. Discusses no graduates this year and diversion program and how to track graduates after program completion. Working with other counties. Not a red flag. Just needs updated.
 - g. Justice Programs Coordinator wage increase update by Heidi Becwar. Heidi went to Personnel Committee on April 2, 2025. It was approved for a six and twelve month pay bump up together with future cost of living increases to follow along per county practice.
 - h. MOU update by Susan Hilger. Have old one on record. Will discuss updates in September.

- i. Handbooks were updated update by Susan Hilger. Discusses update process and wanting to review two times per year to keep with the current Treatment Court standards. Crawford County Treatment Court Participant Handbook updated 5/11/25, Crawford County Treatment Court Policies and Procedures Manual updated 5/11/25, Crawford County Diversion Program Participant Guide updated 5/15/25, Crawford County Diversion Program (Pre and Post Charge) Policies and Procedures Manual updated 6/2/25.
- j. Trainings update by Susan Hilger. Tons of trainings attended within our region. Met with Scenic Bluffs while at the training in Wisconsin Dells. Florida training was well worth going to. Two people from Crawford County went. Diversion Standards training was also attended. Susan was able to go to other counties for training to get perspectives of how other Treatment Courts handle hearings and graduation ceremonies. The committee as a whole passed on their support to Susan for all of her great work done so far in 2025. Discussion on updates to the residency requirement.
