- e. Crawford County Fair No issues. They had a good turnout for the demolition derby.
- f. Crime Stoppers Golf Outing Event was held on September 3, 2025. Great turnout and raised approximately \$7,500.
 - g. Drug endangered children Working on an MOU and procedure with DHS.
