#### Call to order

# Approval of Minutes

Orr moved; DuCharme second to approve the minutes of the July 23<sup>rd</sup> Personnel Committee meeting. The motion carried with no negative votes cast.

## Certified SW New Pay Category

Last year, to attract more applicants for the social worker positions, the job description was changed from "social work certification is required" to "social work certification is preferred." This change has allowed three positions to be filled. All three employees are currently working toward obtaining their certification, but adjusting the job description has clearly helped with the recruitment.

Now, Dan is asking the committee to consider offering an additional dollar per hour for positions held by employees who already have proper certification. This would compensate those who are fully certified. Dan is seeking approval to create this new pay grade and will next go to Finance to secure funding.

Orr moved; DuCharme second to approve creating a new pay grade, adding \$1.00 more per hour for Social Workers with the proper certification. The motion carried with no negative votes cast.

## Funeral Leave Policy

Kyle Kozelka, Hwy Commissioner, asked the Personnel Committee to consider amending the Funeral Leave policy to provide a full day off for employees to attend the funeral of a co-worker within the same department.

The amendment would include the provision that granting the full day off is at the department head's discretion, ensuring that county services are not interrupted and that department operations continue without disruption.

Linda Redman, Register in Probate, raised specific questions about the proposed wording. The committee agreed that the current allowance of just four hours is insufficient for attending and grieving a fellow employee.

Cornford moved; Orr second to have corporation counsel draft an amendment to the Funeral Leave policy allowing a full day of leave for employees within the same department. The motion carried unanimously.
