

Public Safety Minutes June 10, 2025 The meeting was called to order at 9:30 a.m. by Chairman Gari Lorenz. The members present were Greg Russell, Carl Orr, Sarah Nelson, and Brad Steiner. In person attendees were Sheriff Dale McCullick, Joe Morovits, Coroner, , Julie Cipra, 911 Coordinator, and Deputy Nathan Bremmer. The meeting was verified as having been posted.

Motion by Steiner and second by Russell to approve the May 6<sup>th</sup> meeting minutes. The motion carried with not negative votes.

**Coroner:** Not much to report a the time of the meeting. Will be headed to a Conference the next month. Motion by Russell and second by Steiner to approve the bills. No negative votes.

**911 Coordinator-** Julie reports that last month 3 dispatchers went to a training conference. She received the final bill for the map printing. The new Communication Center is taking up a lot of her time, as she is working on getting quotes for new consoles for the dispatch center, along with other storage cabinets. She will be applying for a new grant when it opens in July and closes at the end of July for the Dispatch Center. Julie also took a walk through of the new Dispatch Center after the meeting.

Motion to approve the bills by Steiner and second by Russell, no negative votes cast.

**Emergency Government-** Nothing to report by Sheriff McCullick, EM Specialist Myhre not in attendance. Motion by Russell and second by Orr to approve the bills, no negative votes cast.

**Public Health Officer-** Not in attendance at this meeting.

**Public Safety Report-** Sheriff McCullick advised the committee that the new transport van has arrived. There are 33 currently in jail. Sheriff McCullick advised that the Gunner Pitzer has transitioned from the jail to patrol on night shift.

We currently have two part time jail deputies in the jail academy at SWTC. Will also need to work on hiring a new jailer to fill Deputy Bremmer's position, as he has been appointed to the new Jail transition team. Will also have a female jail deputy leaving on maternity leave very shortly, but do have her spot filled with part time staff while she is gone.

The parades in Eatman and Seneca have been cancelled due to the Highway 35 construction.

Deputy Bremmer gave the committee an update on the new jail progress. Reports that crews are working hard and keeping things on track for an April 2026 completion for the new jail and dispatch center. The jail is really starting to take shape with masonry work ongoing inside and jail cells forming. Lots of electrical, plumbing and HVAC work is being started. As well as fire suppression systems. Stone work on the exterior of the building continues and will continue till about August. Crews have completed the east side of the building and are currently working on the northeast side then will work on the south side.

He continues to meet daily with Kraemer Brothers onsite as well as attend any meetings necessary for the project.

Motion by Russell and second by Lorenz to approve the bills, no negative votes cast.
