# Airport candidates' interviews

**Don Ogilvie-** has been with the Airport Commission for 9 years. He reviewed the pros and cons of the last several years as well as things he looks forward to continuing to work on.

**Donna Flamme**- Chilmark resident, engineering background, pilot, worked on charting software. Currently on the airport Finance Committee.

Matthew Sudarsky- Lives close to the airport. He feels there should be an abutting property owner represented on the commission.

### **Grant Writer**

There was a discussion about how to spend the license plate fund. There was a thought to use money from that fund to contract/hire someone to find additional resources. Also, a possibility to work with MVC or share the services of this person.

### **Committee Updates**

- Finance Committee Doug- Nothing to report
- Land Use Committee Tristan- Looking at the RFP & Lease for 29 Breakdown Lane,
   Tisbury. Also working on how to proceed with work on the courthouse. Doug would like

to set a meeting and Tristan would like to hold off on requesting a meeting without a plan. Christine decided Martina would set a meeting with CAB in the middle of March, to review the courthouse.

- Legislative Committee Christine- she met with our state representative last week. The
  housing issue in the state forest was reviewed. It was brought up that we want more
  representation for the island at the state level. Several of the commissioners met with
  the Commissioners from other counties where there was a discussion of funding for
  courthouses and deeds excise tax proposed law changes.
- Communication Committee Doug- The Op-Ed was printed in the paper. It is a goal to have more of them printed in the future. They have revised phase 2 for Studio Z which now prioritizes updates to the website in advance of the hosting company's upgrade. The cost for phase 2 is \$6,000.

Doug/Tristan moved to approve moving forward with phase two for \$6,000 and pay for it from the Cape and Island License Plates. All in favor.

# Manage r's Report

Appointments- The deadline has expired for applications, it was January 31<sup>st</sup>. A discussion was held on how to review appointments going forward. DCC would like the last Airport commissioner and the new applicant as alternate to the Cape Cod Municipal Health Group to be invited to the next meeting for an interview.

Edgartown has requested some adjustments to the contract for Norton Point. Land Use will review the contract requests before the March 5<sup>th</sup> meeting of DCC when the Edgartown Parks & Rec Department is scheduled to come to discuss the proposed changes.
