Through the Chair, First Selectwoman Drugonis spoke prior to the meeting being adjourned. She stated that a commissioner had come to her office two weeks ago to request alcohol at a Citizens fundraiser. She stated that if a company wants to have a company fundraiser and people want to bring their own alcohol, that is different because you are not serving it. There have been several occasions where there have been issues at both firehouses with alcohol. In speaking with the Chief and in speaking with Kurt, except for the family outings, when there are things for the fire department to do, she stated that if it starts at 6:00pm, cutoff must be at 9:00pm. There must be set hours. Discussion was had regarding hiring an alcohol trailer with permits and insurance. First Selectwoman stated that she is offering an olive branch in allowing alcohol to be served only between the hours of 6:00-9:00pm to show that the companies have the issue with alcohol under control. Having alcohol available is not for drills, not for fires, not anytime- just for events. Chief Edwards will be notified during a chief's meeting of any upcoming event and there will be dual coverage scheduled if necessary.
