Seymour officials claim they made no such statement. Trintiy church is working with Stewardship Realty to possibly build affordable housing on church property. She will follow up.

Question #19 – why do we care if there is a written lease?

Question #22 should be eliminated - too personal

Question #25 - are we liable if they tell us about an issue and we do not help?

Questions #26 & 27 are too vague. What does "Cost" include?

Questions # 29, 30 & 31 - Why?

Questions #32 & 33 should list the AMI & FMR and ask if they were aware.

Question #35- speculative, what purpose?

Question #37 - ask for reasons

Question #46 has 7 obstacles, but asks for rank for only 1 to 6.

Question #47 Out - who would be responsible to answer them?

Question #48 – why only rents?

Question #50 – Out – we are not social services

Our consensus is that this questionnaire is TOO long! People are busy and most would give up before finishing.
