

She discussed her disappointment in not changing the nature of the Town Meeting. She also discussed her disappointment in not introducing combining Town and Board of Education budgets.

Solicitor's Ordinance

- The Police Department is tightening up the ordinance then will come before the Ordinance Committee then the revised Ordinance will come back to the Board of Selectpersons
- Annmarie discussed the current process for a solicitors permit

Senior Citizen Tax Incentive

- Town Counsel, Richard Buturla is going to get some information from OPM
- This will be discussed further at the Ordinance Committee next month.

ITEM #7: Discussion and possible action regarding Final Report from the Charter Revision Commission Tom Gardella, 8 Lantern Drive, Chairman of the Charter Revision Commission. He discussed the Final Report that was brought to the Board of Selectpersons. He discussed the summary of the proposed changes to the Seymour Charter.

Differences between the draft and the final report:

- 1. No longer a recommendation for shared services.
- The proposed amended charter contains, in general, the current budget process with the exception of the addition of the provision providing the annual town meeting with the power to also increase a proposed appropriation.
- The proposed amended charter modifies the required training and education of the town treasurer.
- 4. The proposed amended charter changes references of "First Selectman/First Selectwoman" to "First Selectperson"

There was some confusion on the draft report and final report. Charter Revision Commission Chairman Gardella clarified.

The board members made varying comments regarding the removal of the proposed shared services section, the Annual Town Meeting and the quorum requirements for the Annual Town Meeting.

Al, Fred and Theresa thanked the Commission for all their hard work and effort.

Town Counsel, Richard Buturla, stated that the board can approve or reject in whole or part. He discussed the process.

ITEM #14: Public Comment.

Kristen Harmeling, 134 Davis Road, thanked the board for the general consensus regarding decrease or increase for the budget. She asked for help from the Town to help the Board of Education at the Annual Town Meeting. She asked for help in explaining to the public why they can't get out a revised budget out in two weeks. She asked the board for support.

Debbie Alterio, Oxford, spoke about Hoadley's Pond. She asked to spend money now to take care of it. She stated what would happen if that pond floods and it's not being addressed correctly. She discussed various scenarios.

ITEM #15: Selectperson's Public Comments.

Scott congratulated Jay Uliano to Commander at the Seymour Police Department. He stated he is a very positive asset in the administration. He offered praise to the Public Works Department for their paving they have been doing on specific areas around town.

Al thanked the Charter Revision Commission. He stated they did a great job and had great debates. He is happy they took into consideration the board's comments and recommendations.

Fred stated September 16th will be the Special Town Meeting for the funding for Bungay school. The Adjourned Town Meeting (Referendum) to vote will be held on October 9th. Everyone has a vote on October 9th.

Theresa wished everyone a happy school year. She discussed her concerns about speeding on Skokorat Street and Maple Street. She asked for some more police presence on those streets. She asked about a position that was posted – Housing Ordinance Enforcement Officer. Kurt explained what the position encompasses. This would be a part of the Land Use Department. Kurt stated they anticipate this position to be 100% budget neutral based on the production they have seen from the Blight Department.

ITEM #16: Comments from the First Selectwoman.

- · Annmarie spoke about and gave a little update on Hoadley's Pond
- Wished everyone a great school year
- Enforcement is being conducted on roads now that school is open
- She is happy about the budget workshops. She stated that if a resident wants to increase or decrease a line item, it is important to have the department heads and Board of Education there to explain and answer questions.
