Roads

- o Bungay Road: Currently the area from Bungay Terrace to Emma Street is a one way going up the hill. There are several signs that state ROAD CLOSED. The reason it is one way up hill is the retaining wall on the down side of the hill (the side closed) is being built, in the next week or so they will be digging up the road and starting to replace all the drainage and catch basins along the other side of the road. The road will only be wide enough to fit one car. The construction company has added additional signs. I asked about putting a police officer there to turn people around who are ignoring and going around the signs. This is only one way until this section of the project is done. We ask that everyone please do not ignore the signs. There have been several missed accidents. Once the road construction is completed and before the asphalt plants close there will be another layer of asphalt place down to even out and make the road level with the manhole covers and storm drains.
- Walnut Street Drainage work and repair has started.

- Just a reminder that there is no parking in the Auto Zone parking lot. On special occasions, they do give a few spots. The parking lot across of Bank America is currently open for parking. The State of Connecticut is allowing the town to use this as parking. Parking lot next to the Fish-by-pass.
