- 1) Meeting called to order at 6:30 p.m.

- 3) Public Comment: Gayle Warhola of 85 West Street, Seymour, CT spoke to the Board Members about three road safety suggestions. The first request is for a crosswalk across Broad Street. Chief Bucherati stated that it is pending approval because it is a state road. The second request is for branches to be trimmed on West Street at Falls Hill and install a warning flashing red light sign ahead because of the blind curve. 5) Management Report:

Chief Bucherati attended several meetings throughout the month of October. They went over federal immigration efforts and local law enforcement. In the Supervisors meeting, they issued a new policy concerning the Police Department's compliance with the CT Trust Act. Also, Chief Bucherati gave trend statistics for Seymour Police Department comparing 2024 to 2025 and then commended the patrol division on doing a great job. A special election for referendum on Bungay School was held and no issues were reported. Administration was made aware of a personnel issue and the State's Attorney was notified. There was a loudermill hearing in conjunction with Human Resources and the Chief of Administrative Officer of the Town regarding an employee which is pending at this time. The trunk or treat took place with no incidents.
