### **November Chief's Report**

The 2026 Chief Meeting dates were voted on and approved. We have added Engine 11 and Engine 15 to all town-wide calls, operating 24/7, and are in the process of rewriting the running rules accordingly.

The Bungay Road project traffic has returned to two lanes as of today. The response card for that area has been reverted to normal operations.

Training continues to go well. In October, we conducted a department drill with the Connecticut State Police FEIU K9 Unit. On November 18th, we will be hosting a class on "New England 2½-.Story Wood Frame Fires." Six members are registered for the upcoming winter Firefighter I class, and one member recently passed the 2Q class.

We received one complaint from a member regarding another member, which the Chiefs will be reviewing. Additionally, one member is currently serving a 30-day suspension, which has already been communicated via email.

Will be starting the 2026/2027 budget next month

All winter Fire Police gloves have arrived and are currently being distributed. Finally, all Swift Water Rescue equipment has been received. We will be scheduling training before placing the equipment into service. This equipment was purchased through grant funding.
