**ITEM #7: Update on Bungay School Building Project**

Fred Stanek gave an update on the Bungay Elementary School Building project.

December 15<sup>th</sup> the Department of administrative services will announce if we are on the priority list for this year and what our reimbursement will be. The Application will go to governor's office for review and then to legislature and hopefully the legislature will take action in late May/early June to approve the reimbursement amount.

He discussed the tentative schedule: December 9<sup>th</sup> hope to possibly approve RFQs/RFPs for consultants and architects. January 13<sup>th</sup> the committee will review bids and schedule interviews. February 9<sup>th</sup> planning interviews with architects and consultants. March 10<sup>th</sup> the committee will recommend an architect to be hired. March – December 2026 the committee decides on the design of Bungay school it will be 10-12 months to design. From February 2027 to July 2028 will be the construction of the school and they hope to open in the Fall of 2028. Fred stated he is optimistic. Bob asked what happens if the town does not get approval. Fred stated we would have to file a new application by June 30, 2026.




