Dr. Compton called the meeting to order with the Pledge of Allegiance at 6:48 PM

B. Opening of Meeting by the Superintendent – Dr. Compton

II. ELECTIONS

A. Temporary Chairperson

Dr. Compton asked for nominations for a temporary chairperson Pete Kubik nominated Kristen Bruno as the temporary chairperson

Ms. Bruno was appointed as temporary Chairperson

Dr. Compton turned the meeting over to Ms. Bruno, temporary chairperson

B. Chairperson

Ms. Bruno, temporary chairperson, asked for nominations for the Chairperson of the Board of Education Mr. Champagne and Mr. Kubik nominated Kristen Bruno for Chairperson of the Board of Education Hearing no further nominations, the nominations were closed and called for a vote.

For Ms. Bruno as Chairperson, eight (8) yes votes – Mr. Behuniak, Ms. Bruno, Mr. Champagne, Mr.

Ms. Harmeling nominated herself for Vice-Chairperson of the Board of Education.

DISCUSSION: Ms. Harmeling stated that her self-nomination was not intended as a challenge to Mr. Champagne. Rather, she believes the Board functions more effectively when there is representation from both political parties. She noted that maintaining the same structure yields the same results and expressed that it is time for a change.

Mr. Champagne stated that he will continue to do his best and will support Ms. Bruno to the best of his ability.

For Mr. Champagne as Vice-Chairperson, there were five (5) yes votes – Ms. Bruno, Mr. Champagne, Mr. Kubik, Ms. Nespoli and Mr. Strumello

For Ms. Harmeling as Vice-Chairperson, there were three (3) yes votes – Mr. Behuniak, Mr. Garofolo and Ms. Harmeling

By a vote of 5 to 3, Mr. Champagne was elected Vice-Chairperson for the Board of Education.

D. Secretary

Ms. Bruno called for nominations for Secretary of the Board of Education

Ms. Harmeling nominated herself for Secretary of the Board of Education

Hearing no further nominations, the nominations were closed and called for a vote.

Passed unanimously, by a vote of 8-0, Ms. Harmeling was elected Secretary of the Board of Education.
