There are four officers in various training academies and interviewed a lateral candidate and are currently in the background phase for another candidate. Chief Bucherati updated and disseminated the new Statewide Uniform Crowd Control Policy that was issued by POSTC. There were no issues with the events that took place in December and all were a success. Chief Bucherati attended various meetings in December and also met with David Martin at Northwest CMED to discuss the dispatch transition. If the funding for the project is approved, he stated they will begin to implement a comprehensive transition plan. Chief Bucherati attended Recruit T. Tomasella's graduation in December and he is doing well on his 12 week FTO program.

hopefully they can transition to the model they discussed to avoid any kind of issues with vehicles. Commissioner Koskelowski asked how many cars are used for patrol. Deputy Chief Fappiano stated there are about 18 cars and about 12 are used as frontline vehicles.

Officer Gallo stated he reached out to other departments to compare the number of officers with K-9's and used ChatGPT to create a list of the types of breeds used in K-9 and recommended a dual purpose German Shepherd as the best option. Officer Gallo and Commissioners discussed the different breeds, their purposes and their life span. Chief Bucherati stated that there is selection process and they currently have a list for officers to sign up for a K-9 and they will involve the Board Members.
