1. Call to Order

Chairman Stuart Brannen called the meeting to order at 7:17 PM
All present stood, saluted the flag, and recited the Pledge of Allegiance.

2. Roll Call

A quorum was present.

3. Election of Officers

A. Chair

J. Baryla nominated Stuart Brannen for Chairman of Beautification Commission.
Seconded by N. Chucta. Vote: 4-0-1 (S. Brannen abstained)

B. Vice-Chair

S. Brannen nominated Nancy Chucta for Vice-Chairman of Beautification Commission.
Seconded by J. Anderson. Vote: 4-0-1 (N. Chucta abstained)

C. Secretary

J. Anderson nominated Jeff Baryla for Secretary of Beautification Commission.
Seconded by Z. Succow. Vote: 4-0-1 (J. Baryla abstained)

4. Public Comment

McKenzie shared that he submitted his "2026 Revitalization Program" to all Adopt-A-Spot members. Guidelines include illumination, clearance around signs, recommending native plants, a variety of pollinators for the spring and summer, and more. Chucta liked that native plants were recommended. Anderson agreed, hoping new guidelines will help.

5. Approval of Meeting Minutes

A. October 16, 2025

Chairman Brannen noted the misspelling of "Keith" on line 5A.
Motion by N. Chucta to approve the Oct 16, 2025 regular meeting minutes, with stated correction. Seconded by Z. Succow. There was no discussion. Motion carried 5-0.

Motion by J. Baryla to approve the Nov 20, 2025 regular meeting minutes as presented. Seconded by S. Brannen. There was no discussion. Motion carried 5-0.

A. Monthly Trail Manager's Report

7. Old Business

A. Update on Collaboration with Seymour Land Trust

Baryla spoke on the preparation of the upcoming "Field, Forest, and Stream" event to be held at the Henry Hamel Environmental Building on Saturday Feb 21 at 11:00 AM. The Land Trust had approved funding to provide refreshments for guests and participants. Baryla added that a volunteer or two would be needed to assist with the activity and possibly the distribution of the refreshments. Hot chocolate will be made on-site. Brannen and Chucta offered to assist at this event. Baryla thanked them both. Brannen asked that an overview of the activity be emailed to him, so he can better prepare for it. Baryla will draft this and send it to both Brannen and Chucta.

There was no further discussion. Motion carried 5-0.*

Monthly Trails Report for January 15, 2026

Paramount (pollinator garden) [PPG]

No recent work performed. Next Work Parties will be planned for Sat Feb 7 and Sat Mar 7.

Keith Mitchell Forest [KMF]

Work Party scheduled for 01/17. Pulling border privet in advance of minor reroute of Falls Trail. Additional Work Party planned here for Sat Feb 28. We will slowly begin addressing all the issues outlined in the ERT summary (barberry patch, erosion, autumn olive patch), as well as planning the first spring clean-up of the adjacent Seymour Land Trust Parcel.

Little Laurel Lime Ridge Park [LL]

Nancy and I performed work along the paper street on 12/20 (2 hrs). Next Work Party here is proposed for Sat Jan 31. No major work planned here until all entry points are addressed.

Gary Park (18 Osprey) [GP]

No Work Party here until spring when we'll target knotweed and begin planning trail restoration.

Fountain Lake North/South [FLN/FLS]

New Year's Day Walk/Hike was canceled due to very high wind gusts (35mph). The Beautification Commission wants to discuss possibly rescheduling it. I will suggest Sat Jan 24 at 12 PM, immediately following my meet & greet event at Heav'nly Donuts. Next best is Jan 31 after LLLRP

Seymour Land Trust parcels [SLT]

No recent work or activity at any. "Field, Forest, and Stream" event at SLT, Sat Feb 21 at 11 AM. Allie contacted me saying \$200 was authorized for refreshments for guests (donuts/hot chocolate)
